

Terms of participation for the Battery Expert Forum

The following participation terms and conditions apply to all forum, conference, seminar and training events of the BMZ Group. Deviating general terms and conditions of the participant are not valid. In addition, the "General Information" attached to the respective conference programmes applies.

1. Registration/Registration Confirmation

1.1 The offers of BMZ GmbH are always non-binding.

1.2 Registration is required for participation in our events. Registration can be done via the Internet, letter or email. It must be completed in full and sent to the Organiser in accordance with these Terms of Participation.

1.3 Registration becomes legally binding through our confirmation, which usually takes place via email. The reference to a completed registration does not represent confirmation. If reference is made to processing deadlines, these are not binding.

2. Registration deadline, number of participants

The registration deadlines result from the respective offerings. The number of participants per event is limited.

Since by experience, the demand exceeds the offered participation places, early registration is recommended. The time of receipt of an application is the determining factor.

3. Venue location

The venue location is stated in the respective invitation to register.

4. Event times, event content

4.1. The event times result from the respective invitations. These are not binding. We reserve the right to cancel individual events, e.g. in case of illness of a lecturer/speaker. We endeavour to notify participants of cancellations or necessary changes, in particular a change of lecturers, as soon as possible.

4.2 Programme changes are expressly reserved, as long as the overall character of the event is respected. Changes of speakers, insignificant changes in the scheduling of events or a reasonable transfer of the venue do not entitle the participants to reduce the price or withdraw from the contract.

5. Termination, cancellations, cancellation fees

5.1 After the beginning of the event, an ordinary termination is no longer possible. The minimum contract term lasts until the end of the event. The right to terminate for good cause remains unaffected. The termination must be in writing. The decisive time for setting the deadline is the organiser's receipt of the termination statement.

5.1. Participants may terminate or cancel their registration up to 3 days before the event date. The cancellation must be made in writing (letter) or by e-mail to info@battery-experts-forum.com. A telephone termination/cancellation is not possible.

5.2 The following cancellation fees shall apply:

- For cancellations up to 8 weeks before the event: 50% of the participation fee.
- For cancellation of participation submitted 4 weeks before the event: 80% of the participation fee.
- For cancellation less than 4 weeks before the event or non-participation: 100% of the participation fee

5.3 A substitute participant may be appointed. For this purpose, the name and address of the substitute participant must be communicated in advance by e-mail to info@battery-experts-forum.com.

5.4. The above cancellation conditions shall also apply in the case of an (short-term) illness of the seminar participant.

6. Payment terms and conditions, default, withdrawal

6.1 The total amount of the participation fee shall be payable upon invoicing. Default occurs 30 days after receipt of the invoice according to § 286 III BGB.

6.2 If payment is not made on time, the organiser reserves the right to withdraw from the contract. Participation in the event in case of non-payment of the invoice is excluded.

7. Liability

7.1 Liability is excluded unless it is covered by one of the exceptions stated.

7.2 We are liable for damages that are based on an intentional or grossly negligent breach of duty by BMZ GmbH, its legal representatives or vicarious agents. Furthermore, liability for injury to life, limb and health, for breach of essential contractual obligations and in the Product Liability Act remains unaffected. Significant contractual obligations are those whose fulfilment is necessary to achieve the objective of the contract and on the compliance with which the contracting party relies and regularly relies. In the event of a breach of material contractual obligations, the claim for damages shall be limited to the typically foreseeable damage, if this was not caused deliberately or through gross negligence, unless it concerns claims for damages due to injury to life, limb or health.

8. Event cancellation, force majeure

8.1 BMZ GmbH shall be entitled to cancel an event for economic or organisational reasons. In this case, the already paid participation fees shall be refunded in full.

8.2 If due to a force majeure or other reasons for which it is not responsible (e.g. a loss of power supply), BMZ GmbH is forced to vacate one or more exhibition areas temporarily or for a longer period of time or postpone or shorten the event, no withdrawal or termination rights shall apply. A refund of already paid participation fees shall not take place.

8.3 Any cancellation and rebooking fees for the means of transport or accommodations booked by the participant shall not be refunded.

9. Data protection

BMZ Group protects your personal data. BMZ Group shall treat the data provided by the participant as confidential and use it only in accordance with the data protection regulations. Personal data is considered all data stored in connection with the name. The inventory data transmitted by the participant/customer (first name, last name, delivery and billing address, e-mail address, depending on the payment method also account details, credit card number, expiration date of the credit card) shall be stored and used by BMZ Group in the subscriber or participant file and - if necessary - passed on to contracted service providers. Unless otherwise specified by the purchaser, the BMZ Group in future shall inform about its events and, if necessary, contact them by fax, e-mail or telephone. The BMZ Group shall take the greatest possible precautions for the security of your data.

10. Photographing, filming, video recording and drawing

During the event, photos and possibly videos shall be taken and used in part on the Battery Experts Forum website and for promotional purposes. By participating in the event, you agree to permit the use of the photos and videos in which you may appear for the described purposes.

11. Applicable law, jurisdiction and place of performance

11.1 German law shall apply to the exclusion of the UN Convention on the international sale of goods.

11.2 If the participant is a registered trader, a legal entity under public law, or a special fund under public law, the place of performance and place of jurisdiction shall be Frankfurt.

12. Severability clause

Should any provision contained in these conditions be or become ineffective or should a gap arise, this shall not affect the validity of the remaining provisions. The ineffective provision or the gap shall be deemed replaced by the effective provision which comes as close as possible to what BMZ GmbH and the Purchaser would have agreed upon if they had recognised the ineffectiveness or gap.
